STUDENTS, WHO HAVE SCORED AN AVERAGE OF MINIMUM 55% (45% FOR RESERVED CATEGORIES) IN AGGREGATE IN PART I (Semester I & II) & PART II (Semester III & IV) IN CBCS CURRICULUM UNDER UNIVERSITY OF CALCUTTA OR ANY UGC APPROVED UNIVERSITY IN INDIA AND HAVE APPEARED IN PART III (Semester VI) IN 2025 (RESULT PENDING) MAY ALSO APPLY; **THE ADMISSION, HOWEVER, SHALL BE PROVISIONAL, SUBJECT TO THE FULFILLMENT OF MINIMUM ELIGIBILITY CRITERIA AS MENTIONED ABOVE.**

THERE WILL BE A COMMON ADMISSION FOR BOTH THE SPECIALISATIONS, I.E., SPECIALISATION IN ACCOUNTING & FINANCE AND SPECIALISATION IN MARKETING. SPECIALISATION WILL BE GIVEN IN THE SECOND YEAR (SEMESTER III) AFTER SUCCESSFUL COMPLETION OF SEMESTER II AND ON THE BASIS OF THE PERFORMANCE OF THE STUDENTS IN 1ST YEAR (SEMESTER I AND II).

NO STUDENT SHALL BE ELIGIBLE FOR ADMISSION AFTER A LAPSE OF MORE THAN FIVE YEARS FROM THE YEAR OF PASSING THE PREVIOUS QUALIFYING EXAMINATION. THE YEAR OF ADMISSION WILL NOT BE TAKEN INTO ACCOUNT WHILE CALCULATING FIVE YEARS FROM THE YEAR OF PASSING THE PREVIOUS QUALIFYING EXAMINATION.

SUCH A STUDENT MUST SUCCESSFULLY COMPLETE THE B.COM [HONOURS/MAJOR] OR BBA/BMS [HONOURS/MAJOR] DEGREE AND SUBMIT THE FINAL MARKSHEET(S) BY 31ST OCTOBER, 2025. THE STUDENT MUST HAVE OBTAINED THE MINIMUM REQUIRED MARKS IN THE HONOURS/MAJOR PAPERS (55% MARKS FOR GENERAL AND 45% MARKS FOR THE RESERVED CATEGORY).

IF A STUDENT FAILS TO COMPLY WITH THE ABOVE NORMS, THE ADMISSION WILL BE CANCELLED AND THE STUDENT WILL HAVE TO WITHDRAW, AND NO FEES WILL BE REFUNDED.

NON-COMPLIANCE WITH THE ELIGIBILITY CRITERIA WILL LEAD TO REJECTION OF THE APPLICATION.


